DEADLINE FOR REGISTRATION: 13 January 2020

DEADLINE FOR SUBMITTING A COMPLETE PAPER: 28 February 2020

Formal requirements of the paper and instructions for its processing will be published on the conference web site. In the event of non-participation at the conference or failure to submit the paper, the conference fee cannot be recovered.

CONFERENCE FEE: 70 EUR

The fee may be paid solely by means of a wire transfer based on an e-invoice that will be issued upon the registration for the conference.

ACCOMMODATION: Participants shall arrange their accommodation themselves.

COLLECTION OF PAPERS: Reviewed collection of papers with an ISBN No. assigned to it will be produced in an electronic (CD) form and will be permanently accessible on the website of the conference and the website of the Faculty of Law at CU. Furthermore, it will be incorporated into the library database systems. Kindly note that only papers of the participants who attend the respective discussions at the conference will be published in the given collection of papers.
