






Maria Karcz-Kaczmarek Ph.D

Prof. Dr. Elemér Balogh



Prof. Dr. Elemér Balogh graduated from the Faculty of Law of József Attila University in 1983. He is the founding head of the Department of European Legal History and served as the dean of the Fculty from 2016 to 2019. He teaches European constitutional and legal history, as well as criminal law history at the Faculty of Law and Political Sciences. From 1989 he spent three years studying at the University of Freiburg, where he earned his doctorate. In 2002, he was appointed as a university professor, then in 2005, he was elected as a constitutional judge for a nine-year term. In 2015, he was awarded the title of Honorary Citizen of Szeged. His primary research areas include the history of German criminal law in the 18-19th centuries, medieval ecclesiastical jurisdiction, and the history of copyright law.



She has been working in higher education for more than 14 years, including work on domestic and international projects, different seminars and conferences and published work. Research areas are foreign investment law, international investment disputes, citizen participation in the development of public policies and in the last few years her research focus has been on the relationship between law and digital technologies, in particular artificial intelligence (AI) – regulation; legal, ethical and social aspects, the impact of AI on human rights. The goal of the course is to demonstrate manners in which arbitral tribunals deal with determination of applicable law for the substance of investment disputes. It includes analysis of the principle of party autonomy (including comparative view of BITs of Hungary and Serbia) and cases where the choice of law clause is absent. Focus is on case-law.



Dr. Gáspár-Szilágyi is an Assistant Professor in EU and International Economic Law at Birmingham University. Prior to this, he worked as a Lecturer in Law at Keele University (UK), as a postdoctoral fellow at the PluriCourts Centre of Excellence at the University of Oslo (Norway), as a postdoctoral fellow at the University of Amsterdam, and as a Lecturer at the Hague University of Applied Sciences. He defended his PhD in 2015 at Aarhus University in Denmark. He also holds a two-year LLM from Maastricht University (the Netherlands, top 3%) and an LLB from Babes-Bolyai University (Romania, valedictorian). He is an editor of the European Investment Law and Arbitration Review and sits on the editorial board of the Yearbook of Socio-Economic Constitutions. He regularly publishes on topics concerning international investment law, EU investment law, EU external relations, and regional economic integration.



The gradual rise of China as an economic power has resulted in more protectionist measures in the West. With the proliferation of investment screening mechanisms in the EU, the restrictive national measures will have interesting consequences in terms of the existing treaties for the protection of foreign investments. The course will inform students about the international law aspects and potential consequences of these recent developments.



Nurzhan Yeshniyazov



Nurzhan Yeshniyazov is an associate professor at the M. Narikbayev KAZGUU University Law School in Astana, Kazakhstan. In 2001, he graduated from the International Law Department of Al-Farabi Kazakh National University and taught there until 2013. In 2017, he defended his PhD dissertation at KAZGUU University. He underwent internships at the United Nations University of Peace, the Max Planck Institute for Comparative and Private international Law in Hamburg, the Christian Albrecht University in Kiel, and has given guest lectures at the Martin Luther University in Halle-Wittenberg and Tashkent State University of Law. Prof. Yeshniyazov is the author of the first Kazakh textbook on international civil procedure (2012) and an article-by-article commentary on Kazakhstan's legislation in the field of private international law (2023). He leads the Antenna for the Hague Conference on Private International Law in Central Asia and coaches student teams in Jessup, Vis, and PAX Moot Court. In addition to private international law, he has a research interest in several branches of international public law, particularly international security law, armed conflicts, and international economic law.

From the beginning of her professional career, she has been cooperating with the largest law firms, training institutions and private and public universities, author of many publications in the field of economic, civil and compliance law, both in Polish and English.

The content of the course, inter alia, covers the following issues: ways of legal acquisition of agricultural land in Poland, restrictions for such acquisition and the effects of violating legal norms problem of acquisition (including acquisition) cross-border of agricultural real estates and agricultural holdings in the Republic of Poland, with particular emphasis on the issue of regulating the acquisition of agricultural real estates as an instrument for the protection of family farms, current legislation, jurisprudence and doctrine.

The aim of the course is to present Starting from fundamental notions, on to the participants the principles of which the whole course will be based such as a real estate, an agricultural real estate (land), an agricultural holding, an individual farmer, a family holding - the course proceeds to detailed issues concerning the acquisition of ownership of agricultural land (holdings), including inheritance, acquisition of other rights on agricultural land, establishment of a relation in the form of a lease of agricultural land and also acquisition of shares (stocks) in companies that own agricultural land. Next, the course presents the constitutional norm of the agricultural system of the Polish state and raises the issue of Polish regulations in the context of EU freedoms.



Jérémy Floutier



Jérémy Floutier is a PhD candidate at the University of Szeged and Paris Panthéon-Sorbonne University, pursuing a dual degree program since 2017. His primary research topic is the portrayal of Transylvania in Hungarian and Romanian education. For Jérémy, history has always been a passion and a means to understand his own identity and the world around him. He believes that historians play a vital role in society, offering a balanced perspective on important issues in contrast to political and ideological viewpoints. His research aims to comprehend the discrepancies between Hungarian and Romanian historical narratives and shed light on their significance for both nations. Jérémy acknowledges the challenge of conducting research in two foreign languages (Hungarian and Romanian) but sees it as an advantage. He currently teaches at the University of Szeged and at the Université catholique de l'Ouest, and in a couple weeks he is due to defend his thesis.



Romanian-Hungarian relations are characterized by an intense historical-memorial quarrel over a territory - Transylvania - that lies at the heart of both national constructions. This course aims to analyze and deconstruct these divergences in order to understand the representation of the *other* and the identification of Romanians and Hungarians with Transylvania.

Dr. Dildar F. Zebari earned a BA in Law from Dohuk University, Iraq, and later completed a Master in Laws at the University of East London. Between 2011 and 2014, among others, he taught at Duhok Polytechnic University, served as the Director of the Department of Legal Issues, and led the university's anti-corruption committee. He also worked as a legal advisor for an oil service company in the Kurdistan region of Iraq. In 2014, he received a scholarship from the Kurdistan region and the Hungarian Government to pursue a PhD at the University of Szeged, which he successfully completed in 2019 with a dissertation on "Investment Protection under the Energy Charter Treaty." During his PhD, he actively participated in conferences and published eight articles in various international journals. He also gained practical experience during an internship at MOL Group's legal department in Budapest and later worked as a legal advisor and international coordinator for Hevestherm Kft. Today, Dr. Zebari serves as an Assistant Professor and Dean of Akre Technical College, making substantial contributions to the field of law and academia.
