If the international travel ban will not be lifted until the date of the Academy, the online participation opportunity will be available to the students. If the ban is lifted, the students are required to attend the Academy in person in Greece.

Costs:

A. Regular participation

- the administration fee of the program is 880 € (including tuition, participation to the courses and access to the non-printed materials, certificate of participation, participation at the European Group of Public Law Conference)
 - plus, accommodation (approx. 800-900 €), travel (approx. 400 €) and personal costs (food 20-30 €/day), insurance (based on your individual booking).

B. Online participation

- Synchronous e-learning fee is 800 € (including tuition, participation to the online courses and non-printed materials, certificate of participation, online participation at the European Group of Public Law Conference)

Support from IRSI:

1st installment: 324.000.- HUF (paid in advance, in HUF, as a scholarship, irrespective of the changes in the EUR-HUF relation)

2nd installment (paid only in case of travelling to Greece and personal attendance): 459.000.- HUF (paid afterwards, in HUF, as a scholarship, irrespective of the changes in the EUR-HUF relation)
