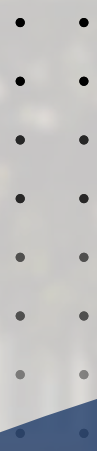

HUMAN RIGHTS AND CLIMATE CHANGE

Climate change poses one of the most significant threats to human survival, demanding an urgent response and an international approach to this issue. Regional human rights systems could serve as an ideal platform for individuals to challenge states that fail to uphold their responsibility to avert the adverse impacts of climate change and to ensure affected individuals have access to effective remedies. In this context, the lecture will explore whether the climate emergency can be addressed through the human rights standards established by the European Convention on Human Rights. Additionally, the outcomes of the 29th United Nations Climate Change Conference (COP29) will be analyzed from a human rights perspective. The lecture will contribute to the ongoing discussion on whether the human rights arena is the right place for the climate change battle.

WOMEN IN CONFLICT RESOLUTION AND PEACE PROCESSES

In this lecture, the prospects and problems regarding women's participation in peace processes are presented.

DIGITAL MARKETS ACT EXPLAINED: LAW, INNOVATION, AND GEOPOLITICS IN PRACTICE

The EU's Digital Markets Act (DMA) represents a regulatory turning point, shifting competition policy from ex post enforcement to ex ante obligations on large digital platforms. While promoted as a global standard pursuing contestability, fairness, and digital sovereignty, convergence across jurisdictions remains limited, with countries adopting diverse digital antitrust regulation (DAR) models shaped by local politics, market conditions, and strategic positioning. The DMA functions not only as competition policy but also as industrial policy, disproportionately affecting U.S. firms while seeking to create space for European champions—yet evidence shows high compliance costs, regulatory capture risks, protectionist motives, degraded user experience, and potential chilling of innovation. Globally, DAR frameworks differ in scope, design, and legal standards: some impose broad per se bans, others favor flexible, rule-of-reason approaches or targeted ex post enforcement, leading to significant regulatory divergence. Ultimately, the DMA illustrates the tension between regulation, innovation, and geopolitics, underscoring the importance of narrowly tailored, evidence-based rules grounded in demonstrable market failures. This course intends to explain the DMA and its effects in a practical way for law students, all within 1.5 hours.

Dr. Kiss holds a JD, an LLM in European and International Business Law, a PhD in Law and Social Sciences, and an LLM in U.S. Law from George Mason University. Prior to her U.S. research and teaching, she participated in international research initiatives and instructed EU business law to JD and LLM students, while also serving as a senior counselor at the Hungarian Ministry of Justice, advising on EU law and policy. Her diverse academic and policy background informs her work at the intersection of regulation, competition, and innovation in global digital markets.

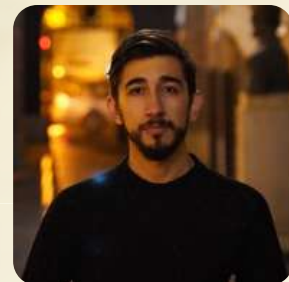
SECURITIZATION OF IMMIGRATION IN THE GLOBALISED WORLD

HUMAN TRAFFICKING – AN ATYPICAL CRIMINAL OFFENCE WITH MULTIPLE PARTICULAR ASPECTS

Cristian Dumitru Miheș, is an Associate professor at the University of Oradea, Romania and leads the Faculty of Law in the Dean capacity.

His area of expertise is Criminal and Forensic Sciences, Criminal Law, Business Criminal Law, European Criminal Law, and the impact of new technologies on the administration of justice. Professor Miheș's publications and research areas include criminal justice, European law, cybercrime, corporate crime, and the influence of AI on law.

Prof. Dr. Miheș founded and currently serves as the editor-in-chief of The Journal of The Faculty of Law Oradea. He participated in specialization courses on International and European Criminal Law at The International Institute of Higher Studies in Criminal Science (ISISC), University of Palermo, Siracusa-Italy and Academy of European Law, Trier-Germany.

Prof. Dr. Miheș has been involved in various projects, including those focused on the impact of internet trade liberalization on pharmaceutical crime, compliance assessment of legal frameworks, and criminal law protection of EU financial interests. Since 2017, Professor Miheș has been practicing as an Attorney at Law.



THE RIGHT TO AN EFFECTIVE INVESTIGATION IN THE CONTEXT OF TRAFFICKING IN HUMAN BEINGS: EUROPEAN STANDARDS AND NATIONAL PRACTICE

Ante Novokmet, Ph.D., is an Associate Professor and Vice Dean for Business, Development, and Projects at the Faculty of Law, Josip Juraj Strossmayer University of Osijek. He received his law degree from the same institution and completed postgraduate studies in Criminal Law at the University of Zagreb, where he defended his doctoral thesis on “Judicial Control of Accusation.”

Dr. Novokmet teaches at both undergraduate and postgraduate levels in law and public administration. He has been involved in several key research projects funded by the Croatian Science Foundation, including those focused on judicial cooperation in criminal matters and negotiated justice models in Croatian criminal procedure.

Dr. Novokmet has notably contributed as a consultant for the EU and Council of Europe's joint initiative on procedural safeguards in judicial proceedings and served on the working group of Croatia's Ministry of Justice for the National Judicial System Development Plan 2022- 2027.

Dr. Novokmet has held research stays at the Max Planck Institute in Freiburg and serves on the committee for the international conference “EU and Comparative Law Issues and Challenges” (ECLIC), where he is also the executive editor of the related publication.



HUMAN TRAFFICKING CASES IN THE HUNGARIAN PROSECUTORIAL PRACTICE

Julianna Huszár

Hungarian Public Prosecution Service



Since January 2017, Julianna Huszár has been working at the Office of the Chief Public Prosecutor of Csongrád-Csanád County, where she has specialized in serious and organized crime. From June 2017 onward, as a prosecutor at the Office of the Prosecutor General of Hungary, she has been actively involved in shaping policy on trafficking in human beings (THB), both from theoretical and practical perspectives.

Her work includes contributing to the development of guidelines aimed at improving the investigation and prosecution of THB cases. In recent years, she has delivered numerous lectures on the topic, primarily for investigators and fellow prosecutors.

Julianna Huszár maintains close professional relationships with representatives of the Ministry of Interior—particularly those involved in drafting Hungary's National Strategy on THB—as well as with victim support services and non-governmental organizations.

In recognition of her dedication and contributions, she was awarded the Human Dignity Protection Award by the Ministry of Justice in the previous year.



PROTECTION OF VICTIMS OF HUMAN TRAFFICKING IN TURKISH LAW

Selman Dursun

University of Istanbul



Assoc. Prof. Dr. Selman Dursun graduated with honors from Istanbul University Faculty of Law in 1999. He completed his master's degree (2002) and doctoral studies (2009) at the Department of Public Law, Institute of Social Sciences, affiliated with the same university.

Since 2000, he has been serving as a research assistant and faculty member in the Department of Criminal Law and Criminal Procedure Law at the same university.

Currently, in addition to his role as the Head of the Department, he also serves as the Director of the Center for Criminal Law and Criminology.

DURSUN has conducted scientific research in Germany for his doctoral and associate professorship studies. In addition to general and special provisions of criminal law and criminal procedure law, he has worked in the fields of economic criminal law and victimology.



THE EFFECTS OF DIGITALIZATION ON MIGRANT SMUGGLING AND HUMAN TRAFFICKING IN THE CONTEXT OF MIGRATION AND HUMAN MOVEMENTS CAUSED BY POLITICAL DEVELOPMENTS

Adem Sozuer

Bilgi University, Istanbul



Professor Adem Sözüer, Head of the Department of Criminal and Criminal Procedure Law at Istanbul Bilgi University, previously served as department head and director of the Criminal Law and Criminology Research Center at Istanbul University. He conducted doctoral and post-doctoral research at the Max Planck Institute for Foreign and International Criminal Law with support from the Alexander von Humboldt Foundation.

He played a central role in Turkey's Criminal Law Reform, contributing to the drafting of the Criminal Code, Criminal Procedure Code, and key laws on execution of penalties, misdemeanors, police powers, and protection against domestic violence.

Founder and president of the International Crime and Punishment Film Festival, he has also organized major international legal events and launched the Istanbul Criminal Law and Criminology Archive series. Author of many books and papers in Turkish, German, and English, he frequently engages with media and civil society on human rights, women's rights, fair trial, freedom of expression, and combating discrimination.



INVESTIGATION OF HUMAN TRAFFICKING CRIME IN POLAND – CURRENT CHALLENGES

Barbara Dudzik

Maria Curie-Skłodowska University, Lublin



Barbara Dudzik works as an Assistant Professor at the Department of Criminal Procedure at the Maria Curie Skłodowska-University in Lublin (Poland).

Dr. Dudzik received degree of Doctor in Law on the basis on the thesis “Resumption of judicial proceedings ex officio in the Polish criminal procedure” (2009). Her research focuses mainly on Polish criminal procedure, European and International Criminal Law and Procedure, disciplinary responsibility of academic teachers.
