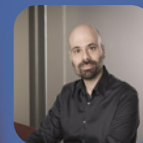

## MALICIOUS CYBER ACTIVITIES IN THE CONTEXT OF INTERNATIONAL LAW

Proliferation of malicious cyber activities causes harsh consequences not only for the enjoyment of human rights as well as national security of states, but also may threaten international peace and security. At the same time the difficulties of attribution in cyberspace alongside with the growing use of AI to carry out malicious cyber operations may lead to misinterpretation of the situation and as a result to political tensions between states or even to a military conflict. The lecture addresses possible legal qualifications of malicious cyber activities and suggests possible measures of self-help that states may resort to respond them.

## LAW AND CODIFICATION

This mini-course will deal with codification of the law. Codification is of interest both for its historicity and for its current impact on the regulatory frameworks of different jurisdictions. This mini-course aims to leave behind an exclusively local approach to codification. In doing so, it will adopt a holistic approach departing from various jurisdictions, thus achieving a global understanding of this fundamental legislative tool across time and space. A comparative legal historical approach helps to better understand codification. Reflecting on similarities and differences amongst jurisdictions and periods can help develop broader contexts, bridging disciplinary boundaries, while fostering knowledge transfer.

This mini-course will address methodological and substantive aspects of codification. It will first offer conceptualizations, to be followed by theoretical explanations of the shifts within codification. Attention will then be devoted to comparative legal history as a tool to identify those shifts. Experiences in Europe and the Americas will ultimately illustrate the malleability of codes, with a special focus to private law. The mini-course will conclude with reflections on the value of legal transplants for the development of codification.

He received his degree of LL.M. at Louisiana State University Law Center (USA), where he was Research Associate at the Center of Civil Law Studies during 2006-2010. He received his degree of PhD at Maastricht University, where he was Researcher at the Department of Methods and Foundations of Law during 2011-2015.*

## MARITIME TRADE AND COMPARATIVE LEGAL HISTORY

### The Case of General Averages

General Averages are amongst the most ancient legal institutions in use today. While perhaps even pre-dating the Romans, General Averages are still of great importance to international commerce. For instance, the well-known case of the Ever Given - the large container ship which blocked the Suez Canal in 2021, causing enormous financial impact to international trade - was settled by way of General Averages. The amount paid was of 540 million dollars. The principle governing General Averages is simple: if a damage is incurred in order to save the rest of the ship and its cargo, then all interested parties must contribute to it. This simplicity, however, is only apparent: General Averages have been used by different people across different regions and historical periods, throughout a variety of legal systems. How did the same principle interact with different legal cultures across time?

The question can be broadened still: what makes a legal principle of commercial law change? Are changes driven only by economic reasons, or do other factors also play some role?

## THE MOST IMPORTANT INSTITUTES OF FAMILY LAW - COMPARATIVE PERSPECTIVE

During this course students should get to know the basic institutes of family law. Also during the course special emphasis will be placed on comparative models concerning family issues through Serbian legislation in comparison with legal solutions of some countries of the European Union.

### OBJECTIVE OF THE COURSE:

The objective of the course is to adopt the basic concepts of family law, to observe the connections and differences between family law and other branches of civil law, as well as to learn about institutions and institutes of family law in different legal systems.

### COURSE OUTCOME:

It is expected that by mastering the course program, the student can successfully:

- Explain the basic institutions of family law in the legal system;
- Identifies and explains the connection and difference between family law and other branches of civil law;
- Demonstrates the ability to apply theoretical knowledge and adequate legal norms from the field of family law to a specific legal relationship (marital/common-law union, domestic violence and family law protection against violence, child rights, parental rights and their protection, foster care, adoption, guardianship).

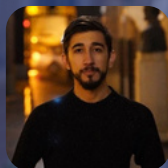

## THE ROLE OF CASE LAW IN THE MAKING OF THE CIVIL LAW TRADITION

In “*The Civil Law Tradition*”, J.H. Merryman argued that the main distinctive feature of common law in the role of judges and case law, whereas the civil law tradition is more attached to legislatures and scholars. Is that correct? In his lecture, the Professor will explain how relevant have been - and still are - civil-law judges and their decisions in the making and development of legal institutions.

*Aniceto Masferrer is Professor of Legal History and teaches legal history and comparative law at the Faculty of Law, University of Valencia, Spain. He has been a fellow researcher at the Institute Max-Planck for European Legal History (2000-2003), Visiting Professor at the University of Cambridge (2005), Visiting Scholar at Harvard Law School (2006-07) and at Melbourne Law School (2008), and Visiting Professor at the University of Tasmania (2010), Visiting Scholar at Louisiana State University – The Paul M. Hebert Law Center – (2013), Visiting Scholar at George Washington University Law School (as the Recipient of the Richard & Diane Cummins Legal History Research Grant for 2014), and Visiting Professor at the École Normale Supérieure – Paris (2015). He has lectured at universities around the world (France, Germany, Belgium, The Netherlands, Malta, Israel, United Kingdom, Sweden, Norway, USA, Canada, Australia and New Zealand).*

## Prof. Dr. Krisztina KARSAI

Professor  
University of Szeged



*Krisztina Karsai (DsC, PhD) is professor of Criminal Law at the University of Szeged and serves as the Head of the Unit at the Institute of Criminal Law and Criminal Science at the University of Szeged. In 2022 Professor Karsai was granted the Doctor Honoris Causa title by the University of Oradea (Romania). Prof. Dr. Karsai is an international expert in the area of European and Comparative Criminal Law and has an research portfolio of more than 70 publications focusing on the harmonization of criminal justice systems in Europe. Her publications can be accessed in this [LINK](#). Her current research interests are related to the use of digital solutions and algorithmic decision making in criminal justice, and to the fundamental issues of criminal liability in the light of the development of (neuro)science. Prof. Dr. Karsai is the leader of the Artificial Intelligence and the Legal Order Research Group at the University of Szeged. Since 2012, Professor Karsai has been an independent expert for the European Commission, specializing in criminal justice, crime prevention, and matters related to justice, freedom, and security. Additionally, she is editor and co-author of the Commentary on the Hungarian Criminal Code.*



## Prof. Dr. Liane WÖRNER

*Liane Wörner is a distinguished full professor at the University of Konstanz, Germany, specializing in European & International Criminal Law, Comparative Criminal Law, and Legal Theory. Prof. Dr. Wörner's expertise within the European and International criminal law matters includes mutual recognition as regards enforcing European Arrest Warrants and European Investigation Orders, mutual assistance in criminal matters, legal aid, and legal frameworks for measurements against terrorism. In 2020, Prof. Dr. Wörner was appointed to prepare Section II of the German report on digitalization and criminal law for the AIDP's next world congress; and since 2019 Professor Wörner is a member of the scientific committee of the AIDP. Prof. Dr. Wörner is the Director of the newly founded Centre for Human | Data | Society at the University of Konstanz studying together with numerous scholars from different fields the individual and social implications of datafication, data-centric technologies and their adaption through a transdisciplinary approach. Recently, Prof. Dr. Wörner was appointed the head of the working group "Proposal for a New Abortion Law in Germany." Professor Wörner's influence extends globally, through guest professorships and lectures on comparative criminal law and procedure at the University of Wisconsin Law School in Madison/USA, at the University Istanbul, and at the University of Szeged.*

*Prof. Adem Sözüer has played a pivotal role in driving legislative reforms as part of Turkey's EU accession process. In the realm of education, the department led by Professor Sözüer provides students with a comprehensive curriculum encompassing substantive, special part, and procedural criminal law courses, alongside a wide array of electives including subjects like medical law, environmental law, media law, penal execution law, and criminology. Since 1978, the department has been publishing the Journal of Penal Law and Criminology biannually, which is now internationally indexed in both the Web of Science (ESCI) and Turkish National Index (ULAKBIM), and freely accessible. Under the leadership of Professor Sözüer, the Institute of Criminal Law and Criminology at Istanbul University organizes a criminal law congress commemorating the enactment of the Criminal Code after the reform process in 2005. Since 2011, the department has been responsible for organizing the International Crime and Punishment Film Festival, which serves as a platform for extensive scholarly discussions, bringing together experts from fields such as cinema, law, psychology, sociology, political science, and non-governmental organizations.*



## Prof. Dr. Giuseppina PANEBIANCO

*Giuseppina Panebianco is a Full Professor of Criminal Law at the University of Messina, Italy. She specializes in juvenile criminal law, organized crime, and European criminal law, and has authored numerous publications on these subjects. She teaches criminal law, juvenile criminal law, and comparative criminal law in the law degree programs at the University of Messina. Additionally, she lectures in postgraduate programs, including the "School of Specialization for the Legal Professions" and the PhD School in Legal Sciences at the University. Maria Curie-Skłodowska University



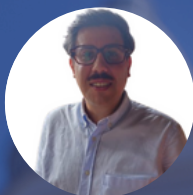
